The Growth Package gives you a financial boost.

What is a day care supplement?

The day care supplement is a supplement for each child that attends a day care centre recognised by the Flanders community in which the fee is not determined by your family income. You are entitled to a fixed amount for each day your child attends the day care.

- For a day with an attendance of 5 hours or more you are entitled to 3,29 euros (amount applicable on 1/4/2021)
- For a day with an attendance of at least 3 hours but less than 5 hours ore you are entitled to 3,29 euros (amount applicable on 1/4/2021)

You will receive the day care supplement for a given month around the 20<sup>th</sup> of the following month:

What do you have to do?

- If you are **already** receiving a **Growth Package**, you **don't have to do anything**. The day care centre will inform us of the days your child attended. The day care supplement will automatically be paid.
- If you **do not yet receive a Growth Package** because you don't live in Flanders but your child does attend a day care centre recognised by the Flanders community which has a fixed attendance fee? Then be sure to return us this application completely filled out and signed via [vlaanderen@parentia.be](mailto:vlaanderen@parentia.be).
